

# How to Think Differently to do Differently

Jamil takes us through a practical understanding of how to cultivate mindsets for optimising talent. Using principles that have been shared with six people who utilised the ideas to become number one in the world in their sport, delegates will be taken through an insightful and entertaining look at how we can create positive change through obtaining different outlooks.

#### The Art of Strategic Thinking
