Technology and Equipment

- What will be provided to students in the exam hall? (e.g. laptop, PC, monitor, keyboard, mouse, charger)
- 2. Per the FAQ, students will be provided with a monitor and a laptop but only a single screen can be used. As the exams are now in person, why can students not use both the laptop and monitor screen?
- 3. Can students use their own keyboard and mouse for the exam?
- 4. What will the operating system be on the laptop/PC provided? (e.g. Windows, MacOS, Linux)
- 5. Will students have access to Excel during a *Paper A* exam format, which is typically done in Word?
- 6. For exams requiring additional software (e.g., R Studio), how will students know the correct software and packages are installed?
- 7. If only particular R packages are downloaded, will the IFoA share a list of these so that students know which packages are missing?
- 8. Will there be screen protectors on the laptop/computer to ensure that student's won't be able to read other screens?

Exam Setup and Materials

- 1. Will a printed copy of the exam paper be provided to students in the exam centre?
- 2. Regarding the question on will the IFoA provide a paper copy of the exam paper, the FAQ mentions that the IFoA "are currently exploring other options with exam centres and will update you shortly". What does this mean?
- 3. Will scrap paper or an A4 whiteboard be provided?
- 4. Will the IFoA provide the Actuarial Tables, or must students bring their own?
- 5. Can students bring their own paper copy of the Actuarial Tables to the exam, and invigilators check that these are free of any personal notes?
- 6. The online exam platform required 2FA. Is this removed for the in person exams?
- 7. For CP3, what materials can students bring to the exam? Will a copy of the prereading material be provided?
- 8. As students cannot take public transport to the exam centre, will there be reserved parking spaces for students?

Exam Conditions and Timing

- 1. Will time reminders be given throughout the exam (e.g, warnings of 1 hour left)?
- 2. Were the exam papers written with the assumption that exams would be closed-book?
- 3. If a student arrives up to 15 minutes late for reasons outside their control, will they still be allowed to enter the exam? Is there a grace period for late arrivals?
- 4. Is there a specific time during which students are not allowed to leave the exam hall after the exam starts?
- 5. Is there a specific time during which students are not allowed to leave the exam hall before the end of the exam?
- 6. What must students bring to verify identity?

Personal Items

- 1. Do items on the "comfort aid" list (e.g., hearing aids) require additional approval to be used?
- 2. What personal items are students permitted to take to the exam with them? (e.g. Watch, stop watch, timer)
- 3. Where can students store personal belongings during the exam?

Exam Contingencies and Accommodations

- 1. Are there spare laptops available in the event a laptop breaks during the exam?
- 2. What is the contingency in place if a laptop breaks during the exam, and their paper cannot be restored?
- 3. Are there any measures in place for the distraction caused by the noise levels of students typing in exam halls?
- 4. What contingency is in place in the event the WiFi drops in the exam hall at the start or end of the exam, when downloading or uploading their paper?
- 5. Are there any accommodations for students taking one exam paper in Dublin and another in Belfast, given the additional travel time and costs compared to those assigned to a single exam centre?
- 6. Are there any measures in place to ensure fairness between students sitting exams in person and those taking them online?
- 7. Will there be an appeal mechanism for candidates unable to travel due to personal reasons?
