

THE SOCIETY OF ACTUARIES IN IRELAND

Alan Barrett

Alan Barrett is a Research Professor with Trinity College Dublin where he is the Project Director with The Irish Longitudinal Study on Ageing (TILDA). He holds this post while on secondment from the Economic and Social Research Institute (ESRI). He is also a member of the Irish Fiscal Advisory Council.

Professor Barrett received his Ph.D. in Economics from Michigan State University in 1994 and joined the ESRI that year. Most of his research work has been in the areas of labour economics, population economics and macroeconomics. His current work involves the use of the TILDA data to explore issues such as retirement expectations, the later-life economic impacts of childhood events and the circumstances of Ireland's older returned emigrants. Between 2005 and 2010, he was a lead author of the ESRI's *Quarterly Economic Commentary*. Between 2001 and 2003, Alan spent two years with the Department of Finance as a Senior Economist. During this time, he worked on the long-term fiscal implications of population ageing.
