Mike Claffey

Mike is a Fellow of the Society of Actuaries in Ireland. He has served on the Society's Council and is currently a member of the Life Committee and an elected member of the Disciplinary Panel.

Mike is a Principal with the Dublin office of Milliman since 2005, having previously worked in a range of domestic and international life assurance companies. He currently discharges the role of Appointed Actuary and Life Reinsurance Signing Actuary for a range of companies headquartered in Ireland.

Gerry Carroll

Gerry is a litigation specialist with WhitneyMoore Solicitors and has handled some of the largest and most complex cases to come before the Irish courts. He also has extensive experience of international litigation practice involving European and US Courts. He has considerable experience of insurance, product liability, automotive, intellectual property and aviation disputes and litigation.

He has a particular interest in acting in the area of professional disciplinary investigations and hearings. For over 20 years he has advised the Complaints Committee (formerly the Investigation Committee) of the Chartered Accountants Regulatory Board (Institute of Chartered Accountants) and has advised a number of Special Investigators in high profile investigations. He regularly appears on behalf of the Complaints Committee as a prosecutor in hearings involving Members of the Institute of Chartered Accountants before its Disciplinary and Appeal Tribunals.
